

INVITATION TO BID NOTICE FOR HIRING OF VEHICLE RENTAL SERVICE

Sealed Technical and Financial Proposals in accordance with Punjab Procurement Rules-2014 (Amended till date), Rule 38 (2) (a), “Single Stage - Two Envelope Bidding Procedure” are invited from interested bidders hiring of Vehicle Rental Service as stated below:

- i. Detailed specifications of required vehicles are mentioned in the relevant bidding document.
 - ii. For Lot – A, bidders must have the capacity to provide maximum 01 Hi Roofs with one driver and one labourer and 05 Toyota Corollas per day.
 - iii. For Lot – B, bidders must have the capacity to provide maximum 04 Mini Trucks at the required time, each with one driver and arrangement of loading and unloading.
 - iv. Lot-wise aggregate lowest evaluated bidder will be awarded the contract for the specific lot in which his bid will be lowest.

 3. Punjab Education Foundation reserves the right to reject all the proposals at any time prior to the acceptance of a bid or proposal.
 4. Interested eligible bidders may obtain bidding documents and further information from the office of Deputy Director (Procurement) only, on cash payment of Rs.500/- (nonrefundable).

Sealed Bids must be delivered to the office of the Deputy Director (Procurement) at **or before 11:00 a.m. on April 29, 2021** and must be accompanied by a **bid security as per above table** which is 2% of the price of procurement estimated by PEF in the form of CDR, Pay Order, Demand Draft, or Banker’s Cheque from a Scheduled Bank of Pakistan.
 6. **Bids will be opened in the presence of representatives of bidders who choose to attend at 11:30 a.m. in the Office of Punjab Education Foundation at 52 – L, Gulberg – III near Kalma Chowk, Lahore, on the date of tender submission.**
 7. Taxes will be deducted as per applicable government rules. NTN and Sales Tax registration certificate must be provided.
