

**INVITATION TO BID NOTICE FOR PROCUREMENT OF POLYPROPYLENE BAGS,

7. **Bids will be opened in the presence of bidders’ representatives who choose to attend at 11:30 a.m. in the office of Punjab Education Foundation at 52 – L, Gulberg – III near Kalma Chowk, Lahore, on the same date of bid submission.**
