- Sealed Bids must be delivered to Dak Section of Punjab Education Foundation located at 52-L, Gulberg – III near Kalma Chowk, Lahore till **11:00 a.m. on December 20, 2022** and must be accompanied by a **Bid Security of Rs.732,000/-** which is 2% of the price of procurement estimated by PEF in the form of CDR, Pay Order, Demand Draft, or Banker’s Cheque from a Scheduled Bank of Pakistan. Late bids shall not be accepted.
- Bids will be opened in the presence of representatives of bidders who choose to attend at **11:30 a.m.** in the office of Punjab Education Foundation at **52 – L, Gulberg – III near Kalma Chowk, Lahore**, on the date of tender submission.
- The Bid shall have a minimum validity period of one hundred and twenty (120) days from the last date for submission of the bid.
- Taxes will be deducted as per applicable government rules. NTN and Sales Tax registration certificate must be provided.
