  - iii) Applicant shall have working experience of 3 (three) years in Printing, logistics, conduct and E-marking of Papers with Govt. Examination Bodies.
  - iv) Applicant must have one office in Lahore.
  - v) Firm should not be blacklisted/in litigation/ in dispute with any Public/Government/Private organization.
