ELIGIBILITY CRITERIA

Eligible Bidder is a Bidder who:

- Registered with Tax Authorities (NTN, GSTN, PSTN) as per relevant laws in Pakistan.
- Provides audited financial statements or copies of work orders / contracts for related items of FY 2015-16 or 2014-15 depicting sound financial strength (minimum Rs.5 million for Lots A ,E,I and Rs. 3 million for Lots B, C, D, F, G and H in a financial year);
- Provides copies of five (05) work orders/ contracts showing supply of related items against each lot applied;
- Provides authorization certificate of distribution/ dealership for the respective lots. (In case of toners, authorization certificate of reseller via dealer or authorization certificate of distribution/ dealership shall be provided);
- Does not apply in the capacity of Joint Venture;
- Has submitted bid security mentioned in above table in form of a Pay Order/CDR/Demand Draft in favor of Punjab Education Foundation as per bid security clause of Punjab Procurement Rules 2014 (amended till date) which states that a procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price of procurement;
- Has purchased Bidding Document from the office of Deputy Director (Procurement) only, on cash payment of Rs. 500/- (nonrefundable).
- Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or autonomous body or Private Sector Organization anywhere in Pakistan.

Note: Verifiable documentary proof for all above requirements is mandatory.

- A pre-bid meeting will be conducted at 11:00 am on April 09, 2017 in order to clarify the queries of the prospective bidder(s).
- The proposals must be submitted in the office of Deputy Director Procurement till April 17, 2017 before 12:00 pm at the below mentioned address.
- Technical Proposals will be opened publically by a Committee at 12:30 pm on the last day of submission of proposals in the presence of Bidders or their authorized representatives who wish to witness the tender opening. After the Technical evaluation, Financial Proposal of only technically qualified bidders shall be opened on a date and time to be announced subsequently.
- Tender Document is available right after the publication of this Invitation to Bid.
- Punjab Education Foundation reserves the right to reject all the proposals at any time prior to the acceptance of bids or proposals.
