Sealed Bids must be delivered to Dak Section of Punjab Education Foundation located at 52-L, Gulberg – III near Kalma Chowk, Lahore till **11:00 a.m. on February 22, 2024** and must be accompanied by **Lot-wise Bid Security as given in above table** which is **02%** of the price of procurement estimated by PEF in the form of CDR/Bank Guarantee / Demand Draft / Pay Order from a Scheduled Bank of Pakistan. Late bids shall not be accepted.
9. Bids will be opened in the presence of representatives of bidders who choose to attend at **11:30 a.m.** in the office of Punjab Education Foundation at **52 – L, Gulberg – III near Kalma Chowk, Lahore**, on the date of tender submission.
10. The Bid shall have a minimum validity period of one hundred and twenty (120) days from the last date for submission of the bid.
11. Taxes will be deducted as per applicable government rules. NTN and Sales Tax registration certificate must be provided.
12. In case of an official holiday on the day of submission, the next day will be treated as the closing date.
