Subject: Guidelines and Instructions Regarding Students Admission-Registration in NSSE

All applicants are hereby informed to strictly adhere to the following instructions and guidelines regarding student admissions under the Nawaz Sharif School of Eminence (NSSE) program:

1. Approval Prior to Admissions

No admissions shall be granted by any applicant school unless and until **final agreement is signed by the Punjab Education Foundation (PEF)**.

- Student registrations can be carried out through the **designated online portal** shared by PEF. <http://nssregister.pefsis.edu.pk/>
- It is explicitly clarified that **registration of students on the portal does not guarantee admission** under any circumstances.

2. Admission Criteria and Eligibility

All admissions shall be made strictly in accordance with the prescribed policies and procedures of PEF.

- Admissions are **subject to the already notified Admission Policy**.
- Students must **qualify the admission test**.
- Verification of **Poverty Means Test (PMT) status** of the applicant's family.

Any deviation from the prescribed criteria will render the admission **null and void**.

3. Admission Test and Schedule

- The **admission test will be conducted by PECTAA**.
- The **schedule and date of the admission test** will be communicated by PEF in due course.

4. Prohibition of Fee Charging

Admissions under the NSSE program are **completely free of cost**.

- No school/applicant is allowed to charge any fee from students or parents under any pretext, including but not limited to:
